Sub: Regarding training for skilled development [BFT]

This is to inform you that, now a days rate of execution of schemes under MGNREGS have been increase manifold than its preceding years. Depending upon this huge work load it is becoming very hard to meet up the technical requirement at the Gram Panchayat level.

In this context it become need of the hour to form a pool of semi technical hands by initiating training from some persons among active worker households / active supervisor having Job Card and received employment in last two Financial Years under MGNREGS.

Willing active worker households / active supervisor may apply in plain paper who have passed Xth standard at the minimum education and age must be between 18 to 40 years as on 01.06.18 [relaxation in age limit will be allowed as per Govt. rules]. After screening from the willing and eligible candidate from the active worker households / active supervisor training will be imparted.


All willing and eligible candidates may apply in plain paper within 22.06.18 upto 4.00pm, enclosing the Xerox copy of Job Card, Xth Pass Certificate and Admit Card, Aadhar / EID No., Voter Card, Cast Certificate, MIS Registration No. (in case of Supervisor) and two copies pass port size photograph.
