I am directed to request you to refer to this Commissions memo no. 513(17)-
SEC/3E-25/2013 dated 22.03.2013, wherein the procedure has been explained for
allowing a person to contest election whose name is not registered in the last finally
published Assembly Electoral roll but whose name has been registered in the
manuscript of continuous updation and a certificate to that effect is submitted in the
proforma prescribed therein. In continuation of the above letter, it is further provided
that in case of persons contesting an election on the basis of the certificate issued by
the concerned ERO, the name of the concerned elector shall have to be incorporated
in the relevant part of the Panchayat Electoral Roll by way of issuing a second
supplement of such part of the Panchayat Electoral roll. A copy of such second
supplement may also be submitted to all the recognized political parties containing
only the names of those contesting candidates, if any and the Contesting Candidates
of the concerned Panchayat Constituencies.

Panchayat Electoral Registration Officers concerned may be informed
accordingly.
