ORDER

Whereas all the personnel engaged under Sarva Siksha Abhiyan including Special Educators, Para Teachers are contractual employees up to the age of 60 (Sixty) years.

AND

Whereas remuneration to those employees are being paid out of Government fund (Central + State).

AND

Whereas the appointing authority of the personnel engaged at the State level is the State Project Director (SPD) and for those at the district level is the District Project Officer (DPO), both of whom are Government Officials.

AND

Whereas certain mandatory provisions under the Right of Children to Compulsory and Free Education Act 2009 (RTE) are to be fulfilled within the stipulated time frame as mandated under the same Act.

AND

Whereas the RTE prohibits the engagement of teachers for any other purpose other than education related matter except some urgent matters like Election, Disaster Management and Census.

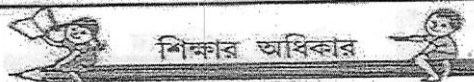
AND

Whereas there is no specific provision in the contractual agreement between the SPD / DPO and the incumbents concerned, which allows long leave to the personnel working under Sarva Siksha Abhiyan.

Now, taking into consideration the above factors, I am directed to inform that any personnel serving under Sarva Siksha Abhiyan will not be allowed to contest Panchayat General Election or any other election to an elected body unless she / he submits an undertaking at the time of filing nomination to the effect that she / he will tender resignation from the post, if, elected.

All concerned are to be informed accordingly.

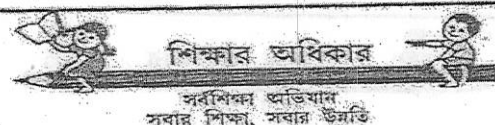
