

In compliance with the solemn order passed by the Hon'ble Supreme Court of India on 28.06.2013, read with the solemn order passed by the Hon'ble Supreme Court of India on 02.07.2013 in the matter of the West Bengal State Election Commission (Petitioners) versus the State of West Bengal & Ors. (Respondents) vide SLP No.19928-19931 of 2013 and in partial modification of this Department's Notification No.405/SS/PN/ O/I/1E-3/2012 Part-II dated 18.05.2013 and in exercise of the powers conferred by section 42 of the West Bengal Panchayat Elections Act, 2003 (West Bengal Act XXI of 2003), the Governor is pleased hereby to appoint, in consultation with the West Bengal State Election Commission, the 11<sup>th</sup> Day of July 2013, the 15<sup>th</sup> Day of July 2013, the 19<sup>th</sup> Day of July 2013, the 22<sup>nd</sup> Day of July 2013 and the 25<sup>th</sup> Day of July 2013 as the dates of poll for elections to Gram Panchayats, Panchayat Samitis and Zilla Parishads to be constituted under the West Bengal Panchayat Act, 1973 (West Bengal Act XLI of 1973) in the districts within the State of West Bengal except those in the district of Darjeeling as per programme stated below and also to appoint 07.00 hours to 17.00 hours on those dates as the time of poll for the said elections.


