
With reference to the above, this is to inform you that the date of poll & counting of votes for Malda district has been rescheduled. Now as per new schedule the election for Malda district will be held on 22/07/13 and counting of votes will be on 29/07/13. Uninterrupted speedy broadband connection is to be provided from your end at the block levels as well as in district level i.c.w. ensuing Panchayat General Election, 2013.

It is high time to send report returns of Law & Order related matters. Due to slowness of the broadband connection in the blocks and frequently brake down of internet connection the work is hampered very much at the crucial time. In most of blocks specially 6(six) blocks under Chanchal Sub-Division and K.Chak-I, K.Chak-II, K.Chak-III, Gazole etc. is totally going on through a bitter experience at the time of uploading the report. More or less in most of the blocks, speed of broadband connection is very slow.

A new system which is called SMS based reporting has been introduced by the W.B. State Election Commission during the DC/ RC and at the time of Poll at the end of the Presiding Officer as well as at the end of the Sector Officer. A huge nos. of SMS will be sent on 21/07/13, 22/07/13 due to election. Hence you are requested to keep necessary arrangement ready so that this SMS can be uploaded smoothly in the Commission Website. In addition to that if any land phone is out of order during this period that should be repaired on priority basis. If any new connection is required to be installed for election purpose that should also be taken on the priority basis.

In addition to that there are so many polling booths or adjacent areas where signal of BSNL is unavailable or weak. Already a C/D has been handed over at your end mentioning the areas of Polling Stations and surrounding areas. Depending on it you are requested to assess the shadow zone and make necessary arrangement to enhance your signal system so that this areas should be covered up during Poll Day i.e. on 22/07/13 or the day before poll.

Your heartiest co-operation is solicited.


