I am directed to state that during the Panchayat General Elections, 2013 it may kindly be ensured that on the poll day the candidate's camp, if any, shall set up beyond 200 metres of a polling station. Such camp should have only one table and 2 chairs and not more than three workers. Where there is more than one polling station in a single premises one additional worker for each such additional station may be allowed. If any slip of paper is issued to a voter for easy identification, such slip shall contain the Part No. & Sl. No. of the voter and not name of any candidate or name of any party or election symbol either in pictorial or descriptive form. If any such slip is received by the polling party, that slip shall be torn and thrown away by them and the Presiding Officer shall ask the camp concerned to stop issue of such slip.

A Polling Agent attending Polling Station shall display his EPIC or an identity card displaying his name and the name of his candidate. There should be no repeat no name of any party or symbol of any candidate displayed on the card. This may be strictly observed.

All Returning Officers contesting candidates and representatives of local units of political parties may be informed accordingly. It is requested that this may be brought to the notice of Observers.
