Sir,

With reference to the above, this is to inform you that an allotment of Rs. 43.08703 /- lakh (Rupees forty-three lakhs eight thousand and three) only has been received to this end on account of minimum repair works on the approach roads leading to the premises of the polling stations i.c.w. the 8th Panchayat General Elections'2013. Few blocks namely H.C.Pur-I, H.C.Pur-II, Ratua-I & Manikchak are in the category of flood oriented. Due to increase in the water level of Ganges, Mahananda, Fulahar and other surrounding rivers the tendency of erosion have been increasing day by day nearer to Polling booth areas and approach roads to the Polling booths.

Recently few shifting proposal of Polling Stations from the above blocks have been received to this end due to the erosion.

Considering the above deteriorated situation you are requested to re-consider the allotment of fund given to this district and make necessary arrangement for allotting further fund for Malda district at the earliest.

Hence your heartiest co-operation in this regard will be highly solicited.
