Sub: Maximum nos. of deployment of CAPF & Outside State Forces in the Polling Booths.

Ref: Vide no. 1930(35)-SEC/3L-5/2013 dated 12/07/13 and no. 1959-SEC/3L-5/2013 dated 14/07/13 of the Secretary, W.B. State Election Commission.

Enclosed please find herewith the above 2(two) memo nos. of the Secretary, W.B. State Elec. Commission regarding maximum deployment of Central Armed Police Forces as well as Armed Police Forces from other States for conduct of Panchayat General Election, 2013. As per memo no. **1930(35)-SEC/3L-5/2013 dated 12/07/13** it is clearly directed from the Commission that 45(forty-five) Coys will be allotted for Malda district from CAPF and Armed Police Forces from other States. Regarding the actual deployment of the CAPF & forces from States outside W.B., the Commission directs to observe the following principles:-

- (i) CAPF & Armed Police Forces from other States should not be kept in reserve for any reason.
- (ii) As the quantum of the above forces is not adequate for deployment in all polling stations, they should be allotted for multi-booth polling premises rated as highly sensitive / sensitive as far as practicable and in sectors keeping in view the local needs.
- (iii) The CAPF should be used for conducting flag marches in the pre-poll as much as practicable for area domination.
- (iv) Forces to be deployed in sectors should constantly move around the localities around polling Stations for area domination to prevent any intimidation of and obstruction to the electors.
- (v) CAPF should not be used for other purposes like NAKA etc. or kept at Police Stations.

You are requested to go through the matter jointly with the local I.C. / O.C. of the police Station and submit the deployment plan of CAPF & State Armed Police Forces actually deployed at Polling Premises / Booths and Sectors to this end within **16/07/13 positively**. This should be treated as Panchayat Election Urgent.
