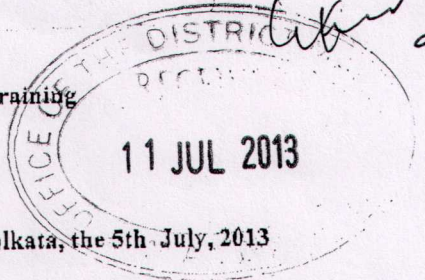

For the purposes of polling, services of teaching & non-teaching staff of Educational Institutions and Premises of Schools & Colleges in the respective panchayat areas according to the phases of Elections as mentioned above may be utilized and requisitioned by the Returning Officers concerned on the dates of polling mentioned above and counting on 29th July, 2013 in the interest of smooth conduct of the Panchayat General Election, 2013.

Under the circumstances, the Governor has been pleased to deploy the services of teaching & non-teaching employees' as required by the District Magistrates & District Panchayat Officers concerned and allow to utilize the premises of institutes under administrative control of Technical Education & Training Deptt. as requisitioned by the Returning Officers concerned for the purposes of polling and other allied matters with effect from the after noon of 7th July to 11th July, 2013 for the 1st phase of election, 11th to 15th July, 2013 for the 2nd phase of election, 15th to 19th July, 2013 for the 3rd phase of election, 18th to 22nd July, 2013 for 5th phase of election and on the day of counting i.e. on 29th July, 2013 in the interest of smooth conduct of such elections.

Premises if required for strong room with the facility of furniture, power, drinking water supply and other utilities should be made available in the said premises in connection with this election.
