

PROCEEDING OF THE MEETING WITH O/Cs OF DIFFERENT CELL, ADMs, SDO, BDOs i.c.w. PANCHAYAT GENERAL ELECTION – 2013 HELD IN THE OFFICE CHAMBER OF THE D.M.,MALDA ON 17/07/2013 AT 03.00 P.M.

The DM initiated the meeting in presence of ADM(G), SDO, Sadar, NDC, DNO NREGS, DPLO, O/C DDM, DP&RDO, T.O.-I & T.O.-II and BDOs. DM asked the DP&RDO regarding how many shifting proposal have been received from the blocks. DP&RDO replied that already 3(three) proposal from H.C.Pur-II and 1(one) proposal from Gazole have been received. Then DM asked all the BDOs present their whether there is any specific shifting proposal or not. All of them except H.C.Pur-II and Gazole assured that they have no specific shifting proposal right now. In case of Manikchak block already 1(one) polling station has been shifted and which is approved from the W.B.S.E.A.C..

BDO, Ratua-I informed the DM in case of Gobindapur Mouze it looks like a island and for security forces a speed boat of civil defence is required. DM instructed O/C, DDM to provide a speed boat to BDO, Ratua-I.

BDO, Gazole informed that there is some hole in the ring bundh which is required to be repaired by the Irrigation department. DM asked ADM(G) to write this in black & white to the Irrigation Department.


DM informed that Political Parties specially President of TMC in Chanchal Sub-division is complaining regarding insufficient Electoral Roll which is given to the contesting candidates. All the BDOs under Chanchal Sub-division said that all the voter lists have been handed over to the respective political parties by DP&RD Office and the voter list for relevant portion of the contesting candidate has been handed over. Hence there is no question of non-receiving of voter list.

DM also informed that Political Parties are also complaining regarding non-receipt of Forms required for appointment of Polling Agent / Election Agent / Counting Agent. All BDOs are assured that sufficient nos. of said Forms were handed over to the respective political parties.

It was decided that Forms & Materials required for Counting are to be purchased centrally at the district end. Senior Staff from Eng.Bazar & Gazole block will come to assess the requirement of such materials & forms. DM directed that ADM(G), O/C, Material Cells will sit together and collectively assess the actual requirement of the said materials & forms.

DPLO & NDC informed the BDOs that few changes have been made in the transportation plan due to shortage of Buses. The details are been explained by the DPLO to the BDOs and it is suggested to them that depending on the new plan they should necessarily change their respective plans.

As there is no other points to be discussed the meeting ended with vote of thanks to and from the chair.


