ORDER

In continuation of this continuation of this Commission's Order No.1470-SEC/1M-19/2013 dated 07.06.2013, it is to state that as regards fresh poll all electors entitled to vote at the polling station or stations in question will also be entitled to cast their votes.

The marks of indelible ink made at the original poll should be ignored at the fresh poll to distinguish the mark to be made at the fresh poll from those already made at the original poll.

The Commission hereby directs that, the mark of the indelible ink should be put on the voter's left middle finger at the fresh poll for other districts except Howrah. As regard Howrah District where a sizeable number of voters within the area of Howrah Parliamentary constituency have also exercised their franchise in the Panchayat General Elections, 2013 may bear the said indelible ink mark on their middle finger. In such cases, the Commission hereby directs that for the purpose of fresh poll in Howrah District, a mark of indelible ink shall be put on the root of the nail of the left hand ring finger of any such elector in place of middle finger.

The matter may be informed to the concerned Panchayat Returning Officers and Presiding Officers concerned accordingly.


