I am directed to state that the permissible limit for use of vehicles by a contesting candidate and movement of vehicles on the day of poll for the ensuing Panchayat General Elections, 2013 shall be as follows :-

1) Permissible limit for use of vehicles by a contesting candidate

- a) In regard to a candidate contesting from a Zilla Parishad constituency, one repeat one four-wheel vehicle may be allowed for his own use and/or for his election agent for which permission mentioning the vehicle number shall be obtained from the Returning Officer;
- b) In regard to a candidate contesting from a Panchayat Samiti constituency or a Gram Panchayat constituency, no repeat no four-wheel vehicle is permitted. A Panchayat Samiti candidate may use a two-wheeler or a three-wheeler which no permission seems necessary.
- c) Each recognized political party shall be entitled under permit to be issued by District Panchayat Election Officer to use one vehicle for each sub-district where the party is participating in the ensuing election.

2. Restrictions on the movement of vehicles on the day of poll

- a) Recognised political party operating in the District may be allowed to use not more than one four-wheeler vehicle for each Block within the district on the poll-day.
- b) There shall not be any convoy of two-wheeler, or three-wheeler, or four-wheeler, having more than 2 (two) such vehicles at any time in any polling area on the poll-day;
- c) No such vehicle, as referred to above, shall be used for transport of any voter to the polling-station on the poll-day.


The candidates and the recognized political party as also the Returning Officers along with Police Officers, on duty may please be informed of this directive from your end.
