In exercise of the power vested with the State Election Commission vide Article 243K(1) of the Constitution of India read with the provisions envisaged in Section 4(1) of the West Bengal State Election Commission Act, 1994 for superintendence, direction and control of the preparation of electoral rolls for, and for conduct of elections to the Panchayats, it is hereby ordered that the District Panchayat Election Officer, Panchayat Returning Officers, Presiding Officers, Polling Officers and any other officers appointed for the conduct of the ensuing Panchayat General Elections, 2013 including all Police officers shall be deemed to be on deputation to the West Bengal State Election Commission for the period commencing from the dates of Notifications calling for such elections and ending with the date of declaration of results of such elections and, accordingly, such officers shall, during the abovementioned period, be subject to the control, superintendence and discipline of the West Bengal State Election Commission.
