Sir,

In order to maintain a proper record regarding uniformity of measure adopted regarding the aforementioned provisions of the act and rules, a model proforma regarding Proceedings of Scrutiny is enclosed herewith for favour of your kind perusal and necessary action. The proforma is to be maintained tier-wise and constituency wise. The PROs are requested to take necessary action to bring the nomination register (as per format supplied from this end) at the place of scrutiny apart from the nomination papers.

The proforma is only suggestive, changes, if needed, may be made.

Note that apart from the Candidate himself/herself or, his/her election agent and one proper can remain present during scrutiny. No other persons (apart from the officials associated with the process) are allowed to enter unless allowed by the Panchayat Returning Officer. Persons remaining present may see/verify the records, if so desires, but cannot physically touch or handle them. As informed earlier, proper security arrangement for conduction of entire process should be made.

This may be treated as PANCHAYAT GENEREAL ELECTION, 2013 URGENT.
