## TERMS AND CONDITIONS

- 1) Tender Form may be collected from the Office of the undersigned "Free of Cost" after submission of prayer for having it on the date and time stipulated. No document needs to be attached while submitting application for getting Tender Form.
- 2) The BID must be accompanied by the following papers duly self-attested by the bidders:-
  - a) Valid VAT Registration Certificate,
  - b) Professional Tax Clearance Certificate,
  - c) Trade License,
  - d) PAN Card,
  - e) VAT Return
  - f) Latest Income Tax Return,
  - g) Requisite Credential Certificate (Completion Certificate / Payment Certificate of a Single Work, Final Bill etc.).
  - h) Any other document not mentioned above but deemed to be necessary to the bidder to prove his / their eligibility.
  - i) GST registration certificate.
- 3) Successful Bidder will have to show all the original documents before issuance of Work Order, if failed the tenderer will summarily be rejected.
- 4) The Bid should accompany with Earnest Money of an amount prescribed in Column 5 of above Table in the form of Demand Draft of Any Branch of Nationalized Bank drawn in favour of The Block Development Officer, Bamangola Development Block, Pakuahat, Malda.
- 5) Before submission of the tender, the contractor must have to visit the work site to judge the local condition from all corners and no complain about the site will be entertained afterwards. It will be presumed that the agency offered the tender rate after review of entire position of the work site.
- 6) Time is the essence of contract. The successful contractor must complete the work within the time limit specified for completion. No extension of time will be allowed except in special case.
- 7) No consumable materials and tools & plants will be supplied to the agency for any work form the office of the undersigned.
- 8) The successful bidder will have to abide by the provisions of West Bengal Contract Labour Rules, 1972 as will be forced from time to time.
- 9) All the works are to be executed according to drawing and specification approved by the authority and the direction of the Engineer-In-Charge is to be strictly followed.
- 10) Incomplete tender will be rejected summarily. The successful tenderer will have to start the work after consultation with the Engineer-In-Charge and will have to complete the work within the time allowed for completion. Otherwise Clause- II will be imposed.
- 11) Tenderer should quote the offered rate in percentage (both in words and in figures) in tender document – on the basis of PRICE SCHEDULE for the respective work.
- 12) This tender is valid only for 180 days.
- 13) Acceptance of lowest tender is not obligatory and the undersigned reserves the right to accept or reject any or all the tenders without assigning any reason thereof.
- 14) Scrutiny of Documents will be done first during evaluation of the tenders. Tenders dropped by ineligible Agency will be rejected.
- 15) **Dropping of Tender / Documents in sealed cover in the TENDER BOX is compulsory. No tender will be received through the postal Department or by Currier Service.**
- 16) EMD of the successful agency will be converted to SD during execution of work. At the time of payment of Final Bill, EMD will be refunded.
- 17) This notice shall form part of terms and condition of the tender and the tenderer is bound to abide by them.
