

NOTICE INVITING QUOTATION

In cancellation of N.I.Q No- 440/DYO/MLD/2018 Dated:- 30/10/2018 due to non submission of sufficient Questioners, Sealed QUOTATIONS are being invited from bona-feed contractors/ suppliers for the following items in the office of the undersigned having fulfillment of following terms and conditions. Intending contractors/suppliers shall put their quotations in their pad in sealed envelope within 27 /11/2018 up to 12.00 P.M. at the chamber of District Youth Officer, Malda, and the tenders shall be opened at the same day at 1.00 P.M.

TERMS & CONDITIONS

01. Only the reputed suppliers/contractors can participate in the quotation process and he/she will have the GST Document, PAN document and Credential, supply of such item.
02. The price will be accepted who will quote the lowest rate.
03. Incomplete Tender will be rejected summarily. The successful bidder will have to execute a formal agreement on a non-judicial stamp paper of Rs. 10/- (Ten) within 3 (three) working days from the date issue of work order.
04. All works will have to be done according to following specification as approved by authority and as per direction of the Additional District Magistrate (Dev.) ,Malda.
05. The QUOTATION received after the due date and time and any change in QUOTATION after opening of QUOTATION will be out rightly rejected. The undersigned will not be responsible for the loss of QUOTATION Form or for the delay in the postal transit.
06. In case of supply Order received, supply & Installation shall have to be completed within Fifteen (15) day of receipt of Supply Order. No extension of time will be allowed except in cases of natural calamities. If any contractor fails to complete the work within the stipulated time, the Supply order will be cancelled automatically.
07. Partial Supply shall not be entertained.
08. The authority reserves the right of accepting and rejecting any of the quotation without assigning any reason thereof.
