

Terms & Conditions :-

1. Cost of Tender Form (non-refundable) has to be paid in cash only.
2. Contractor must submit attested photocopies of Income Tax Return last (3) three years, G.S.T. Registration Certificate with Return update, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License from local bodies as the case may be.
3. Intending tender should produce credentials in similar nature of Complete work of the minimum value of (60%) fifty percentage of the estimate amount put to tender during last (3) three years prior to the date of issue of the tender notice.
4. Contractor must quote rates in absolute numerical values (both in figures and words) against the estimated cost. Rate quoted in percentage term will be rejected.
5. Rate offered by a Contractor in a particular Tender shall be treated as final and subsequent negotiation with that Contractor for change in price shall not be allowed.
6. 16. Acceptance of lowest quotation/tender is not obligatory and the undersigned reserves the right to accept or reject any or all the Quotation/Tender without assigning any reason whatsoever.
17. All works will have to be done according to specification which is approved by the authority and as per direction of the Prodhan, Gangaprasad G.P., Malda.
18. This notice shall form part of terms & condition of tender and the tenderer is bound to abide by them.
19. Payment will be made after necessary measurement and deduction of IT, SD; CESS. As per prevailing Govt. norms from each progressive bill. GST & CST MAY BE DEDUTED AS GOVT. ORDER
20. Work orders will be issued according to present availability of fund.


