NOTIFICATION

WHEREAS regulation 2.3.4 of the Food Safety and Standards (Prohibition and Restrictions on Sales) Regulations 2011 made by the Food Safety and Standards Authority of India, in exercise of the powers conferred by clause (i) of sub - section (2) of section 92 of the Food Safety and Standards Act, 2006 (Central Act 34 of 2006) read with section 26 thereof, prohibits sale of articles of food in which tobacco and/or nicotine are used as ingredients, as they may be injurious to health;

AND WHEREAS, zarda and khaini, containing tobacco/nicotine as ingredients, are also food articles under Section 3 (j) of the Food Safety and Standards Act, 2006;

AND WHEREAS, it is expedient to prohibit zarda and khaini in the State of West Bengal as those are food products containing tobacco and/or nicotine as ingredients;

AND WHEREAS, the Commissioner of Food Safety of the State is empowered, under Section 30 of the Food Safety and Standards Act, 2006 to prohibit, in the interest of public health, the manufacture, storage, distribution or sale of any article of food in the whole of State, for a period of one year;

NOW, THEREFORE, in pursuance of regulation 2.3.4 of the Food Safety and Standards (Prohibition and Restrictions on Sales) Regulations, 2011, and in continuation to Notification No. 45/ HF/ CFS/ 1M - 6/ 2012 (Pt) dated 4th April 2014, the manufacture, storage, sale or distribution of food products where tobacco and nicotine has been used as ingredients including processed/ flavoured/ scented chewing tobacco/ nicotine whether going by the name or form of gutkha, zarda, khaini, panmasala or, by any other name it is available in the market, is hereby prohibited for a period upto 30th April 2015 in the State of West Bengal, in the interest of Public Health.
