B. Venue of opening quotation paper: Administrative office, Chanchal Krishak Bazer. Malda


TERMS & CONDITION OF QUOTATION

- 2) Earnest money of Rs 1000.00 only/ each Toilet block should be submitted by the quotationer along with his quotation in favour of Malda Zilla Regulated Market Committee, Malda.
- 3) Cost of petty repair along with maintenance cost of Muric Acid, Finale, Jhru, Mog, Balti, Bleaching power etc and Toilet block washing chemical etc will be supply by the Lessee. Major repair cost if necessary will be borne by the Malda Zilla RMC.


