
The terms & conditions are noted bellow:

- 1) A) All intending eligible contractor will have to enclose valid documentary evidence in original (for verification by the authority) along with one self attested Xerox copy in support of Income Tax (In modified), GST clearance Certificate , Trade licence, Professional Tax clearance certificate and one copy self attested Xerox Pan Card (both side) along with application. Submitted Self attested Xerox copies will no refund to the applicant.
- B). Venue of dropping of Tender Paper:- Administrative office , PM yard , Mokdumpur, Malda.

C)Eligible contractor will have to enclose self attested Credential Certificate (single work) along with Original of similar nature of work at least 40% of tender price value along with application. (Only last 5 financial year certificate is eligible). If under the one NIT published more than one work then interested person should be submitted separate application along with all documents for each work.

- 1) Last date of application for tender paper :- 28/06/2019 up to 2-00 P.M
- 2) Date for purchased of tender paper :- 01/07/2019 up to 3-00 P.M
- 3) Date for receiving of tender paper 03/07/2019 up to 2-30 P.M
- 4) Date of opening of tender paper :- 03/07/2019 at 3-00 P.M.
- 5) The contractors should be quoted rate both in figure & in words in his / her own hand writing in percentage basis ABOVE / BELOW or AT PER as per tender schedule.
- 6) Earnest money against the work shall be deposited along with tender paper in form of Bank draft from any Nationalized Bank in favour of 'MALDA ZILLA REGULATED MARKET COMMITTEE, MALDA. N.S.C. K.V.P. or Cheque will not be entertained as earnest money and in that case tender will be treated as cancelled.
- 7) Details tender notice and all particulars / documents may be seen by personal call in the office of the Secretary, Malda Zilla Regulated Market Committee, Principal Market Yard, P.O:- Mokdumpur, Malda during office hours on all working days as per specified time. Intending tenderers may remain present at the time of opening of tender. Full postal address should be posted in proper space of the tender. Contractor is to abide by the minimum wages Act of the Govt. of West Bengal and Apprentice Act, 62 of West Bengal.
- 8) Tender paper will not be issue after purchasing date and time of tender as specified in tender notice.
- 9) If issued Tender Paper purchased by the agency but not drop in tender box continuously three times, in that case authority of the Malda Zilla RMC may taken action as per PWD tender norms, Govt of West Bengal.
- 10) Admissible payment / part payment will be made from MZRMC own Fund, when fund will be available.
- 11) In case of unscheduled holydays on the aforesaid dates, the next working days will be treated as prescribed / schedule date for the same purpose.


- 12) The work must be completed within the stipulated time which mentioned in the tender notice from the date of issue of work order.
- 13) The contractor not is allowed in any case to get the work done through any sub-contractor, in case it is detected the tender will be cancelled and the earnest money and security money will be forfeited.
- 14) Additional, substitute item of work is required have to be executed as per rate of concerned current P.W.D schedule, Central circle, Govt. of West Bengal on same tender rate.
- 15) It must be clearly understood by the contractor no claim for enhancement of rates on those already accepted on the ground of fluctuated of market rates or any other reason.
- 16) The contractor undertakes to have the site clean, free from rubbish to the satisfaction of the Engineering- in charge. All surplus materials, rubbish etc will be removing to the places fixed by the EIC and nothing extra will be paid for the same.
- 17) No female labour shall be employed within the limits of a cantonment and no labour below the age of eighteen years shall be employed on the work. Pay Wages Act 1936, minimum Wages Act, and 1948 Employees Liability Act. 1938, Industrial Dispute Act. 1947, Maternity Benefit Act, 1961 and as defined in the C.P.W.D contractors Labour Regulation Act. or as per provision of the contract labour Central Rule 1971, etc whenever applicable should be maintain by the contractor. Local labour has to be utilized as far as possible.
- 18) Contractor should be visit the work site before submitting the tender paper. The security money will be refunded after 6 (six) months from the date of completion of work, If necessary any defect arise of the work within the Security period then contractor bound to rectified the same from his own cost otherwise rectification cost will be deducted from his Security money. Security money of bituminous work will be release after one year.
- 19) The undersigned reserves the right to accept or to reject to all or any tender without assigning any reason whatsoever. There shall be no provisions for Arbitration. Even after submission of tender, the tender will not be taken in to consideration during evaluation. If the paper submitted by any contractor in support of eligibility is found to be false/ baseless, in that case the concern authority, the earnest money which was deposited by the contractor will be forfeited in favour of Malda Zilla Regulated Market Committee.
