- 3) Date of opening of Quotation on 10/12/2018 at 3=00PM
- 4) There shall be fishing right only for 3 (three) years from the date of execution of Lease Agreement deed which will be made a Non-Judicial Stamp Paper worth Rs 10/- only agreeing to the terms and conditions & as per norms.
- 5) @Rs 25% of previous lease rent may be increase as on basic rent.


