Ratification of the decision in the RTA Board, in respect of the issuance of Permit in favour of the applicant Sri Paramanu Baidya for the route from Harishankarpur to Malda via Pakua, Bulbulchandi (2up 2dn) NH at Harishankarpur, which was approved by the District Magistrate & Chairman, RTA Board on 04.10.2015 in the Note Sheet, as it was adopted in the RTA Board meeting dated 02.05.2015 & 01.08.2015, as the applicants offer letter vide Memo 571/MV dated 22.10.2014 for the route from Malda Aambazar to Berhampur was rejected on the ground that the major portion of the route lies upon, in the district of Murshidabad and matter was subjudice.

AGENDA NO. : 04

To discuss and take decision in the matter as stated in the letter issued by the Addl. Secretary to the Govt. of West Bengal, Transport Department vide office No. 3030-WT/3M-06/2008 Pt. dated 11.08.2015 over a complain pertaining to the permit against the holder of the permit Shri Uttam Kr. Roy of Maheshmati, Malda, Permit No. P.St.P NO. 4093/96-97 issued by the Secretary, RTA Malda on 11.10.1996, at present covered by Vehicle No. WB65B/8111 (Bus) in the Route Malda to Berhampore and Malda to Raiganj.

Decision: On scrutiny of the original Permit No. P.St.P No. 4093/96-97 along with the permit register, it is found by the RTA Board, that after curtailment of the route permit covered by the vehicle No. WB65B/8111(Bus) was allowed to ply from Malda to Raiganj in lieu of its original route from Malda to Berhampur and Malda Raiganj as per approval of the then Secretary, RTA, Malda, Shri Lawrence Sitling on 17.02.2014 without approval of the RTA Board.

It is also found from the Permit Register including the original permit that the permit was primarily issued by the then Secretary, RTA, Malda on 14.10.1996 for the route from Malda to Berhampur and Malda Raiganj as per resolution of RTA, Malda dated 08.10.1996 which is against the MV Act 1988.

Accordingly, the Transport Department, Govt. of West Bengal has been requested to take necessary steps as per West Bengal Service Rule against Shri Sitling with the request to pass necessary instruction against the aforesaid permit which was issued in contravention of MV Act 1988.

Shri Uttam Kr. Roy, the present holder of the Permit and the owner of the aforesaid vehicle is being instructed by the RTA Board to stop plying of his Bus covered by the present route permit till the decision is received from the Transport Department by the RTA Board, Malda after giving an opportunity to apply before the RTA Board, Uttar Dinajpur so that he can place his present vehicle on the permit would be issued by the RTA Board, Uttar Dinajpur. The RTA Board, Malda will take necessary steps for issuance of NOC in favour of Shri Uttam Roy against whom the route permit would be issued by the RTA Board, Uttar Dinajpur.

To take decision on the basis of the prayer submitted by Sri Pabitra Talukdar, S/o- Prafulla Kr. Talukdar, Vill- Lakshmipur Colony, PO- Maliha, Ps-English Bazar Dist- Malda for the route Delhi Dewanganj to Farakka via Bhaluka, Ratua, Manikchak, Malda, Kaliachak 1up 1dn NH at Delhi Dewanganj against whom Offer Letter vide Memo No. 605/MV dated 17.11.2014 was issued by the then Secretary, RTA, Malda for the route Malda to Berhampur via Farakka, Jangipur as per RTA Board Meeting dated 14.06.2014 which was not further extended as the major portion of the route

lies upon the district of Murshidabad, though the applicant had already been purchased a new bus on the basis of the Offer Letter issued against him and deposited due Govt. fees for registration.

Decision: It is found from the report of the MVI that the portion of the route Delhi Dewanganj to Teljana out of the total route from Delhi dewanganj to Farakka via Bhaluka, Ratua, Manikchak, Malda, Kaliachak 1up 1dn NH at Delhi Dewanganj is not permissible to be granted as the portion of the route is not road worthy.

As instructed in the RTA Board, the applicant has submitted a fresh application for the route from Teljana to Farakka via Gobra, Bhaluka, Ratua, Manikchak, Malda, Kaliachak NH at Teljana to ply his new vehicle which has not yet been registered and the Secretary, RTA has been instructed to issue offer letter accordingly.
